DECLARATION OF MARC E. MAYER

I, Marc E. Mayer, declare as follows:

1. I am an attorney at law duly licensed to practice law in the State of California and before this Court. I am, through my professional corporation, a partner in the law firm of Mitchell Silberberg & Knupp LLP, attorneys of record for Plaintiffs Nexon America Inc. and NEXON Korea Corporation (“Plaintiffs”). I make this Declaration in support of Plaintiffs’ Request to Enter Default Against Defendant Amarjot Gill a/k/a “Alphaamar.” I have personal knowledge of the following facts and, if called and sworn as a witness, could and would competently testify thereto.

2. Plaintiffs filed the Complaint in this case on January 6, 2012. On March 1, 2012, Plaintiffs filed the Amended Complaint in this case, which named Defendant Amarjot Gill a/k/a “Alphaamar.”

3. Attached hereto as Exhibit A is a true and correct copy of the proof of service on file with the Court, reflecting that Defendant Amarjot Gill a/k/a “Alphaamar” was personally served with the Summons and Amended Complaint on May 12, 2012.


